III. Motion to Approve February Minutes:

IV. Committee Reports

- 1. **Equipment:** Tom Matthews, Chris Morgan and Jim Krick reporting. Need to get key and spreadsheet from Tom Organtini. Decided to not use helmet decals because they would need to be removed from helmets at end of season.
- **2.** Coaches Committee: Tom Hackman reporting. Saturday, May 6th, agreed upon for coaches meeting.
- **3. Fundraising:** See new business.
- **4. Grounds/Maintenance:** Matt Schrum reporting. Need paint and discussed possible options for water supply at field. Chris Morgan and Tom Hackman will look our options.
- **5. Clothing**: Nothing to report.
- **6. Concession:** Lisa Kopcik reporting. Followed up on donation letters. Commitments from BJ's Wholesale, Deiffenbach's, Frito Lay, John F. Martin & Sons, Pepperidge Farms, Berks Packing. Will solicit Boyer's and Dunkin Donuts closer to start of season.

V. BICYFL: Jim Krick and Tom Troup reporting. The following by-laws changes were proposed:

- -Proposal for By-law addition- Article VIII Section 17 (OT rules): "Overtime rules will be in effect for playoff and championship games only. In the event the teams are tied at the end of regulation play, PIAA OT rules shall be in effect."
- -Proposal for By-law addition- Article VIII Section 18 (Sunday Teams): "It is expected that each organization will field a Sunday (Varsity) team at each level (Mighty Mite, Mite, and Midget). In the event an organization is unable to field a Sunday team, they shall petition the league prior to the July BICYFL meeting."
- -Merger with BAYFL was discussed. Representatives from each BAYFL school will be invited to the next BICYFL meeting to discuss the merger.
- -Changes to Mighty Mites level in order to reduce the level of competitiveness were discussed. Clubs voted to keep Varsity Mighty Mites as is, however, clubs voted to further discuss having the JV level run as a scrimmage format, or scrimmage/game hybrid. Our club

discussed, and the consensus was that changing the format will not help to reign in competitive coaches. Decision was made to vote "No" on changing the format for JV level. Also, to offer a suggestion to the BICYFL board that consideration be given to reduce the number of coaches on the field for Mighty Mites to help curb competitive coaching.

- **~Programs & Advertising:** Chris Morgan reporting. High Printing Rep discussed the possibility of them providing a club program for the Little Scouts. Approximate 32 page program including team pictures and rosters. They solicit advertisers and retain 40% of funds raised. The other 60% is used to cover printing costs and any remaining funds are turned over to the club. Potential to raise over \$1,000.00 for club. Need to sign a one year contract. Each player would receive a program and rest would be sold at concession stand.
- **~Scrimmage:** Do we want to attend the Berks Brawl if Oley no longer holds their scrimmage or can we host a scrimmage? Need to find out Oley's plan for this year and discuss further, as we would need manpower and location.
